#### President's Report (Emily Brown)

- Meeting to draft update
  - o There are 17 proposals
  - Information requests
  - Cares act expenditures
  - o DCE \$ per college
  - Settlement payments across Community Colleges

Where did the Student Voice form come from??

- Don't know from where the form came
- Came up in the last 10 days

- Motion made by Tom Grady that the student voice form be pulled from AccessBCC immediately until its purpose and process is agreed upon by the MCCC
- Seconded by Bill Kelly
- Discussion
  - Form not part of shared governance as form implies
  - Nancy Benson and Kelli Hiller who are co-chairs of CGC agree: not part of shared governance system
  - Apparently the form came as part of strategic plan; but should not have been put up without discussion
  - o Form has been up for a while
  - Nancy Benson reports that all who have been working on shared governance are very troubled by this
  - o Kelli Hiller commented that this form must by vetted through CWI process
- Vote on motion: approved
- Jeannie Moniz reports that departments and divisions are asking us to come up with a list of things we would "need" and/or "want" in order to go back in July.
  - Wants to make sure members don't inadvertently agree to anything in these meetings
  - Each department and division will be unique, but this should be a bigger discussion
  - Worried that management will push us, and we won't have any language from the union to back us up
  - If there is no reason to go onto campus, will members be able to work from home?
  - Professional staff would like partial return to campus on a permanent basis
- Perhaps need to refer to health and safety committee to check with what the state is required

Concerns over where Title IX complaints go/routing

- One went to Chad and he is not title IX officer
- Motion made by Sandy Lygren that BrCCC create a dynamic "bucket" for those adjusting workload due to course cancellations for comparison and unity and parity across academic areas
- Seconded by Carlos Almeida
- **Discussion**: none
- Vote: defeated (some member had already left)
- Suggestion: form a committee to look into this issue further
